The dance season runs from August to May. A maximum of 9 monthly payments will be due. At the time of registration in addition to the Registration Fee the Costume Deposit is due. Remaining payments will be due the 1st week of each month. The last payment will be due the first week of May. Payments are due as outlined. **No refunds or deductions may be made because of student absence due to illness, holidays, vacations, or for any other reason.** By signing this you agree to give studio at least **30 days notice in writing** before withdrawal of student or be responsible for paying all unpaid tuition and costume fees. A late charge of \$5 will be added every month a payment is 15 days late. A \$25 fee will be assessed on all returned checks. Shoes and costumes may be ordered through Performing Arts 2000. All ordered merchandise must be paid for in advance or online. All accounts must be paid up to date by April 1st or student will not be permitted to perform in the recital. If for any reason a payment is past due Parent/Guardian must pay a \$15 class participation fee in order for student to participate. The class participation fee will be applied toward any outstanding balance. Parents are asked to bring their student and leave them for their dance lesson. **Parents are not allowed in the classrooms, it is too distracting.** You will be notified if your student is not progressing normally. If you have any questions about your student's progress feel free to ask the teacher. By signing this agreement you understand that there is a certain amount of risk in the activities your student will be participating in. Performing Arts 2000 and its staff, agents or instructors are not responsible for any injury or harm that may occur during the above class activities. You must explain to your student that they must listen to the instructor to prevent harm or injury and there is to be zero horseplay in the classrooms at any time. By signing this agreement you approve of Performing Arts 2000 to use the above student's picture in newspaper, ads, articles, websites, brochures and/or posters pertaining to Performing Arts 2000.
